Consumer Price Index for Elderly Consumers Act of 2009 - Directs the Bureau of Labor Statistics of the Department of Labor to prepare and publish a monthly Consumer Price Index for Elderly Consumers (CPI) that indicates changes over time in expenditures for consumption which are typical for individuals aged 62 years of age or older.

Amends title II (Old Age, Survivors and Disability Insurance) (OASDI) to use such new CPI in the computation of cost-of-living increases for Social Security benefits.

Actions Timeline

- **Jun 11, 2009:** Referred to the Subcommittee on Healthy Families and Communities.
- **May 14, 2009:** Introduced in House
- **May 14, 2009:** Referred to House Ways and Means
- **May 14, 2009:** Referred to the Committee on Ways and Means, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **May 14, 2009:** Referred to House Education and Labor
