Summary

(as of Mar 18, 2009)

Makes it in order at any time on March 19, 2009, for the Speaker of the House of Representatives to entertain motions that the House suspend the rules relating to a measure addressing excessive compensation paid to employees of corporations in which the federal government has a significant interest.

Actions Timeline

- **Mar 19, 2009:** Considered as privileged matter. (consideration: CR H3645-3653)
- **Mar 19, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 257.
- **Mar 19, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 257, the Chair put the question on ordering the previous question, and by voice vote announced that the yeas had prevailed. Mr. Lincoln Diaz Balart (FL) demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day. (consideration: CR H3651-3652)
- **Mar 19, 2009:** Considered as unfinished business. (consideration: CR H3654-3655)
- **Mar 19, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 242 - 180 (Roll no. 142). (consideration: CR H3654-3655)
- **Mar 19, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H3645)
- **Mar 19, 2009:** On agreeing to the resolution Agreed to by voice vote. (text: CR H3645)
- **Mar 19, 2009:** Motion to reconsider laid on the table Agreed to without objection.
