Summary (as of May 21, 2009)

Medicare Lung Cancer Early Detection Promotion Act of 2009 - Amends title XVIII (Medicare) of the Social Security Act to prescribe an increased radiologist service payment for chest radiography (x-ray) services that use Computer Aided Detection technology for the early detection of lung cancer.

Actions Timeline

- **Jun 2, 2009:** Referred to the Subcommittee on Health.
- **May 21, 2009:** Introduced in House
- **May 21, 2009:** Referred to House Energy and Commerce
- **May 21, 2009:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
