Young Children's Social Security Number Protection Act of 2009 - Amends title II (Old Age, Survivors and Disability Insurance) (OASDI) of the Social Security Act to direct the Commissioner of Social Security to issue a new Social Security number to a child in cases where confidentiality has been compromised by reason of theft of related documentation.
