Summary (as of Mar 24, 2009)

Sets forth the rule for consideration of the Senate amendments to the bill (H.R. 146) to establish a battlefield acquisition grant program for the acquisition and protection of nationally significant battlefields and associated sites of the Revolutionary War and the War of 1812.

Actions Timeline

- **Mar 25, 2009:** Considered as privileged matter. (consideration: CR H3840-3847)
- **Mar 25, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 280.
- **Mar 25, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 280, the Chair put the question on ordering the previous question, and by voice vote announced that the yeas had prevailed. Ms. Pingree (ME) demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.
- **Mar 25, 2009:** Considered as unfinished business. (consideration: CR H3852-3853)
- **Mar 25, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 242 - 180 (Roll no. 150). (consideration: CR H3852)
- **Mar 25, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 247 - 177 (Roll no. 151).(text: CR H3840)
- **Mar 25, 2009:** On agreeing to the resolution Agreed to by recorded vote: 247 - 177 (Roll no. 151). (text: CR H3840)
- **Mar 25, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 24, 2009:** Introduced in House
- **Mar 24, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-51, by Ms. Pingree (ME).
- **Mar 24, 2009:** The rule provides for the consideration of the Senate amendments to H.R. 146. The motion shall be debatable for one hour equally divided and controlled by the chair and ranking minority member of the Committee on Natuaral Resources. The previous question shall be considered as ordered on the motion to final adoption without intervening motion or demand for division of the question.
- **Mar 24, 2009:** Placed on the House Calendar, Calendar No. 30.
