(This measure has not been amended since it was reported to the Senate on August 3, 2010. The summary of that version is repeated here.)

Permits land held in trust for the Kalispel Tribe of Indians and the Puyallup Tribe of Indians to be leased for a term of greater than 25 years.

Includes the Puyallup Tribe of Indians, the Swinomish Indian Tribal Community, or the Kalispel Tribe of Indians among those tribes and tribal organizations permitted to lease restricted lands under specified conditions without the Secretary of the Interior's approval.
