Summary (as of Jun 18, 2009)

Stop Very Unscrupulous Loan Transfers from Underprivileged Countries to Rich, Exploitive Funds Act or the Stop VULTURE Funds Act - Prohibits: (1) any U.S. person from engaging in sovereign debt profiteering, or any person at all from engaging in such profiteering in the United States; and (2) any U.S. court from issuing a summons, subpoena, writ, judgment, attachment, or execution in aid of a claim which would further sovereign debt profiteering.

Sets forth required court disclosures in actions involving collection of sovereign debt.

Actions Timeline

- **Jul 23, 2009:** Referred to the Subcommittee on Courts and Competition Policy.
- **Jun 18, 2009:** Introduced in House
- **Jun 18, 2009:** Referred to House Judiciary
- **Jun 18, 2009:** Referred to the Committee on the Judiciary, and in addition to the Committee on Financial Services, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
