Sets forth the rule for consideration of the Senate amendments to the bill (H.R. 1388) to reauthorize and reform the national service laws.

Actions Timeline

- **Mar 31, 2009:** Considered as privileged matter. (consideration: CR H4139-4141)
- **Mar 31, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 296.
- **Mar 31, 2009:** The previous question was ordered without objection. (consideration: CR H4141)
- **Mar 31, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 296, the Chair put the question of adoption of the resolution and by voice vote, announced that the yeas prevailed. Mr. Lincoln Diaz-Balart demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption of the resolution until later in the legislative day.
- **Mar 31, 2009:** Considered as unfinished business. (consideration: CR H4143-4144)
- **Mar 31, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 240 - 173 (Roll no. 166). (text: CR H4139)
- **Mar 31, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 240 - 173 (Roll no. 166). (text: CR H4139)
- **Mar 31, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Mar 30, 2009:** Introduced in House
- **Mar 30, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-67, by Ms. Matsui.
- **Mar 30, 2009:** The resolution provides for the consideration of the Senate amendments to H.R. 1388 and makes in order a motion by the Chair of the Committee on Education and Labor to concur in the Senate amendments. The resolution waives all points of order against the motion except clause 10 of rule XXI, provides that the Senate amendments and the motion shall be considered as read, and provides one hour of debate on the motion equally divided and controlled by the chairman and ranking minority member of the Committee on Education and Labor. H.Res. 289 is laid on the table.
- **Mar 30, 2009:** Placed on the House Calendar, Calendar No. 35.
