Summary (as of Jan 8, 2009)

Retired Pay Restoration Act - Expresses the sense of Congress that military retired pay should not be reduced because a military retiree is also eligible for veterans' disability compensation awarded for a service-connected disability.

Allows the receipt of both military retired pay and veterans' disability compensation with respect to any service-connected disability (under current law, only a disability rated at 50% or more). Repeals provisions phasing in the full concurrent receipt of such pay through December 31, 2013.

Makes eligible for the full concurrent receipt of both veterans' disability compensation and either military retired pay or combat-related special pay those individuals who were retired or separated from military service due to a service-connected disability.

Actions Timeline

- **Jan 30, 2009:** Referred to the Subcommittee on Military Personnel.
- **Jan 9, 2009:** Referred to the Subcommittee on Disability Assistance and Memorial Affairs.
- **Jan 8, 2009:** Introduced in House
- **Jan 8, 2009:** Referred to House Armed Services
- **Jan 8, 2009:** Referred to the Committee on Armed Services, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 8, 2009:** Referred to House Veterans' Affairs
