- **Apr 1, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 305, the Chair put the question on adoption of agreeing to the resolution, and by voice vote announced that the ayes had prevailed. Mr. Dreier demanded the yeas and nays and the Chair postponed further proceedings on adoption until later in the legislative day.
- **Apr 1, 2009:** Considered as unfinished business. (consideration: CR H4284-4285)
- **Apr 1, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 234 - 179 (Roll no. 176).(text: CR H4257)
