Summary (as of Apr 1, 2009)

Requires the House Committee on Standards of Official Conduct, or a designated subcommittee, to investigate immediately, for a report to the House within two months on, the relationship between: (1) the source and timing of past campaign contributions to Members of the House related to a certain raided defense-lobbying firm; and (2) earmark requests made by Members on behalf of the firm's clients.

Actions Timeline

- **Apr 1, 2009:** Introduced in House
- **Apr 1, 2009:** QUESTION OF THE PRIVILEGES OF THE HOUSE - Mr. Flake rose to a question of the privileges of the House and offered a resolution. The Chair directed the Clerk to report the resolution. The Clerk completed the reading of H.Res. 312 and the Chair announced that the resolution met the required threshold under the rule.
- **Apr 1, 2009:** Considered as privileged matter. (consideration: CR H4283-4284; text of measure as introduced: CR H4283)
- **Apr 1, 2009:** Mr. Hall (NY) moved to table the measure.
