- **Dec 2, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Nov 30, 2010:** Mr. Peters moved to suspend the rules and agree to the resolution.

- **Nov 30, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Con. Res. 325.
