## Summary (as of May 11, 2010)

FEHBP Dependent Coverage Extension Act - Extends eligibility for coverage under the Federal Employees Health Benefits Program to a federal employee's, annuitant's, or former spouse's dependent child (currently, unmarried dependent child) who is under age 26 (currently, under age 22) or incapable of self-support because of mental or physical disability which existed before age 26 (currently, before age 22).

- **Jun 30, 2010:** Committee on Homeland Security and Governmental Affairs referred to Subcommittee on Oversight of Government Management, the Federal Workforce, and the District of Columbia.
- **May 12, 2010:** Sponsor introductory remarks on measure. (CR S3633-3634)
- **May 11, 2010:** Introduced in Senate
- **May 11, 2010:** Read twice and referred to the Committee on Homeland Security and Governmental Affairs.
