REAL ID Repeal and Identification Security Enhancement Act of 2009 - Repeals title II of the Real ID Act of 2005.

Directs the Secretary of Homeland Security to: (1) establish by regulation minimum standards for acceptance of state-issued driver's licenses and personal identification cards by federal agencies; (2) establish a negotiated rulemaking process before publishing such standards; and (3) award grants to states to assist them in conforming to such standards.

Prohibits federal agencies from accepting state-issued driver's licenses and personal identification cards after specified deadlines unless such identification conforms to the minimum standards promulgated under this Act.

Actions Timeline

- **Oct 23, 2009:** Referred to the Subcommittee on Information Policy, Census, and National Archives.
- **Sep 14, 2009:** Referred to the Subcommittee on Immigration, Citizenship, Refugees, Border Security, and International Law.
- **Jul 31, 2009:** Introduced in House
- **Jul 31, 2009:** Referred to House Oversight and Government Reform
- **Jul 31, 2009:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jul 31, 2009:** Referred to House Judiciary
