Summary (as of Oct 13, 2009)

Amends Public Law 100-573 (relating to the establishment of the Delaware Water Gap National Recreation Area Citizens Advisory Commission) to terminate the Commission 30 years after the enactment of such law. Deems this Act to have taken effect on October 30, 2008.
