Department of Homeland Security Appropriations Act, 2011 - Makes appropriations for the Department of Homeland Security (DHS) for FY2011 for: (1) the Offices of the Secretary, the Under Secretary for Management, the Chief Financial Officer, the Chief Information Officer, and the Inspector General; (2) United States Customs and Border Protection (CBP); (3) United States Immigration and Customs Enforcement (ICE); (4) the Transportation Security Administration (TSA); (5) the Coast Guard, including funding derived from the Oil Spill Liability Trust Fund; (6) the United States Secret Service; (7) the Office of the Under Secretary for National Protection and Programs Directorate, including for the U.S. Visitor and Immigrant Status Indicator Technology (U.S.-VISIT) project, the Federal Protective Service, and the Office of Health Affairs; (8) the Federal Emergency Management Agency (FEMA), including for state and local first responder grants and for the United States Fire Administration; (9) United States Citizenship and Immigration Services (CIS), including for the E-Verify program to assist U.S. employers maintain a legal workforce; (10) the Federal Law Enforcement Training Center; (11) the Office of the Under Secretary for Science and Technology; and (12) the Domestic Nuclear Detection Office.

Prohibits the use of funds under this Act: (1) to amend the oath of allegiance required under the Immigration and Nationality Act; (2) to prevent an individual not in the business of importing a prescription drug from importing a prescription drug from Canada that complies with the Federal Food, Drug, and Cosmetic Act for personal use; or (3) for planning, testing, piloting, or developing a national identification card.

Requires: (1) the Assistant Secretary of Homeland Security (TSA) to work with air carriers and airports to ensure that the screening of cargo carried on passenger aircraft increases incrementally each quarter; and (2) the FEMA Administrator to submit to Congress, and publish on the FEMA website, a report summarizing damage assessment information used to make a declaration that a major disaster exists, with a national security limitation.
