Summary (as of Sep 22, 2009)

Transparency and Executive Accountability Act - Amends the Ethics in Government Act of 1978 to require individuals subject to financial disclosure filing requirements by virtue of an appointment to a position in the Executive Office of the President to file required reports with the Director of the Office of Government Ethics (currently, with the ethics official of the individual's employing agency).

- **Sep 22, 2009:** Referred to the House Committee on Oversight and Government Reform.
