Transportation, Housing and Urban Development, and Related Agencies Appropriations Act, 2011 - Department of Transportation Appropriations Act, 2011 - Makes appropriations for FY2011 to the Department of Transportation (DOT).

Makes appropriations for FY2011 to the Department of Housing and Urban Development (HUD).

Makes appropriations for FY2011 to: (1) the Access Board; (2) the Federal Maritime Commission; (3) the Office of Inspector General for the National Railroad Passenger Corporation (Amtrak); (4) the National Transportation Safety Board; (5) the Neighborhood Reinvestment Corporation; and (6) the U.S. Interagency Council on Homelessness.

Specifies certain uses and limits on or prohibitions against the use of funds appropriated by this Act.
