Expresses support for the goals and ideals of Workers Memorial Day to honor and remember workers who have been killed or injured in the workplace.

Recognizes the importance of worker health and safety standards.

Encourages the Occupational Safety and Health Administration (OSHA), the Mine Safety and Health Administration (MSHA), industries, employers, and employees to support activities aimed at increasing awareness of the importance of preventing illness, injury, and death in the workplace.

Agreed to without objection.
- **Apr 29, 2010:** Considered as unfinished business. (consideration: CR H3059)
- **Apr 29, 2010:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution, as amended Agreed to by voice vote.(text: CR 4/27/2010 H2900-2901)
- **Apr 29, 2010:** On motion to suspend the rules and agree to the resolution, as amended Agreed to by voice vote. (text: CR 4/27/2010 H2900-2901)
- **Apr 29, 2010:** Motion to reconsider laid on the table Agreed to without objection.
- **Apr 27, 2010:** Ms. Woolsey moved to suspend the rules and agree to the resolution, as amended.
- **Apr 27, 2010:** Considered under suspension of the rules. (consideration: CR H2900-2904)
- **Apr 27, 2010:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 375.
- **Apr 27, 2010:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
- **Apr 27, 2010:** PROCEEDINGS VACATED - By unanimous consent, at 6:56 p.m. on April 29, 2010, Mr. Hoyer asked that the ordering of the yeas and nays on the motion to suspend the rules and agree to H.Res. 375 be vacated, to the end that the resolution be considered as adopted in the form as considered by the House on April 27, 2010.
