Sets forth the rule for consideration of H.R. 627 (Credit Cardholders' Bill of Rights Act of 2009).

Actions Timeline

- **Apr 30, 2009:** Considered as privileged matter. (consideration: CR H5003-5012)
- **Apr 30, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 379.
- **Apr 30, 2009:** The previous question was ordered without objection. (consideration: CR H5012)
- **Apr 30, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 379, the Chair put the question on adoption of H.Res. 379, and by voice vote announced that the yeas had prevailed. Mr Sessions demanded the yeas and nays, and the Chair postponed further proceedings on adoption of the resolution until later in the legislative day.
- **Apr 30, 2009:** Considered as unfinished business. (consideration: CR H5012-5013)
- **Apr 30, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 249 - 175 (Roll no. 224).(text: CR H5003)
- **Apr 30, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 249 - 175 (Roll no. 224). (text: CR H5003)
- **Apr 30, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Apr 29, 2009:** Introduced in House
- **Apr 29, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-92, by Mr. Perlmutter.
- **Apr 29, 2009:** It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Financial Services now printed in the bill. All points of order against the committee amendment in the nature of a substitute are waived except those arising under clause 10 of rule XXI.
- **Apr 29, 2009:** Placed on the House Calendar, Calendar No. 49.
