Summary (as of Mar 6, 2009)

Amends the Continuing Appropriations Resolution, 2009 (division A of P.L. 110-329) to extend until March 11, 2009, specified continuing appropriations for FY2009.

Actions Timeline

- **Mar 6, 2009:** ORDER OF BUSINESS - Mr. Hastings (FL) asked unanimous consent that at any time without intervention of any point of order to consider in the House the joint resolution (H.J. Res. 38) making further continuing appropriations for fiscal year 2009, and for other purposes; such joint resolution shall be considered as read; such joint resolution shall be debatable for one hour equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations; and the previous question shall be considered as ordered on such joint resolution to final passage without intervening motion except one motion to recommit.
- **Mar 6, 2009:** Rules Committee Resolution H. Res. 219 Reported to House. Rule provides for consideration of H.J. Res. 38 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Bill is closed to amendments. All points of order against consideration of the joint resolution are waived except those arising under clause 10 or rule XXI.
- **Mar 6, 2009:** Consideration initiated by previous special order.
- **Mar 6, 2009:** Considered by previous special order of the House. (consideration: CR H3060-3066)
- **Mar 6, 2009:** DEBATE - Pursuant to a previous special order, the House proceeded with one hour of debate on H.J.Res. 38.
- **Mar 6, 2009:** The previous question was ordered without objection. (consideration: CR H3064)
- **Mar 6, 2009:** Mr. Lewis (CA) moved to recommit with instructions to Appropriations. (consideration: CR H3064-3066)
- **Mar 6, 2009:** DEBATE - The House proceeded with 10 minutes of debate on the Lewis(CA) motion to recommit with instructions. The instructions contained in the motion seek to require the bill to be reposed back to the House with sundry amendments.
