Summary (as of Oct 14, 2009)

Emergency Senior Citizens Relief Act of 2009 - Amends the American Recovery and Reinvestment Act of 2009 to extend the \$250 economic recovery payment payable to certain individuals through calendar year 2010.

Applies the Old Age, Survivors, and Disability Insurance tax in 2010 to certain earnings in excess of \$1.29 million.

Actions Timeline

- **Oct 15, 2009:** Referred to the Subcommittee on Railroads, Pipelines, and Hazardous Materials.
- **Oct 14, 2009:** Introduced in House
- **Oct 14, 2009:** Referred to House Ways and Means
- **Oct 14, 2009:** Referred to the Committee on Ways and Means, and in addition to the Committees on Transportation and Infrastructure, and Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Oct 14, 2009:** Referred to House Transportation and Infrastructure
- **Oct 14, 2009:** Referred to House Veterans' Affairs
