Summary (as of Oct 26, 2009)

Real Stimulus Act of 2009 - Prohibits the Federal Communications Commission (FCC) from proposing, promulgating, or issuing any regulations with regard to the Internet or IP-enabled services.

Makes such prohibition non-applicable to regulations that are determined necessary to: (1) prevent damage to U.S. national security; (2) ensure public safety; or (3) assist or facilitate any actions taken by federal and state law enforcement agencies.

Actions Timeline

- **Oct 27, 2009:** Referred to the Subcommittee on Communications, Technology, and the Internet.
- **Oct 26, 2009:** Introduced in House
- **Oct 26, 2009:** Referred to the House Committee on Energy and Commerce.
