**(This measure has not been amended since it was passed by the House on March 19, 2010. The summary of that version is repeated here.)**

Requires the inclusion of the land and interests commonly known as Gettysburg Train Station and its immediate surroundings in the Borough of Gettysburg, Pennsylvania, and the land and interests located along Plum Run in Cumberland Township, Pennsylvania, in Gettysburg National Military Park.

Authorizes the Secretary of the Interior to acquire publicly owned property within the area of the Train Station by purchase, from willing sellers only, if efforts to acquire such property without cost have been exhausted. Prohibits the acquisition of property within the areas of the Train Station and along Plum Run by eminent domain.
