Summary (as of Jan 12, 2010)

Congressional Pay Raise Elimination Act of 2010 - Declares that no automatic pay adjustment shall be considered to have taken effect in FY2011 in the rates of basic pay for Members of Congress under the General Schedule (thus eliminating the pay adjustment for Members for such fiscal year).

Actions Timeline

- **Jan 12, 2010:** Introduced in House
- **Jan 12, 2010:** Referred to House Administration
- **Jan 12, 2010:** Referred to the Committee on House Administration, and in addition to the Committee on Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 12, 2010:** Referred to House Oversight and Government Reform
