Summary (as of Feb 2, 2010)

Energy Assistance for American Families Act - Amends the Low-Income Home Energy Assistance Act of 1981 to authorize appropriations for FY2011-FY2014.

Permits a state to use any allotment from such appropriations to assist households whose income does not exceed 75% of the state median income.

Actions Timeline

- **Feb 23, 2010:** Referred to the Subcommittee on Higher Education, Lifelong Learning, and Competitiveness.
- **Feb 3, 2010:** Referred to the Subcommittee on Energy and Environment.
- **Feb 2, 2010:** Introduced in House
- **Feb 2, 2010:** Sponsor introductory remarks on measure. (CR E122)
- **Feb 2, 2010:** Referred to House Energy and Commerce
- **Feb 2, 2010:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Education and Labor, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Feb 2, 2010:** Referred to House Education and Labor
