Sets forth the rule for consideration of the bill (H.R. 2352) to amend the Small Business Act.

Actions Timeline

- **May 20, 2009:** Considered as privileged matter. (consideration: CR H5815-5821)
- **May 20, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 457.
- **May 20, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 457, the Chair put the question on ordering the previous question and by voice vote announced that the ayes had prevailed. Ms. Foxx demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.

- **May 20, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 244 - 175, 1 Present (Roll no. 274). (consideration: CR H5820-5821, H5822-5823; text: CR H5821)
- **May 20, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 247 - 175 (Roll no. 275). (text: CR H5815)
- **May 20, 2009:** On agreeing to the resolution Agreed to by recorded vote: 247 - 175 (Roll no. 275). (text: CR H5815)
- **May 20, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **May 19, 2009:** Introduced in House
- **May 19, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-121, by Mr. Polis (CO).
- **May 19, 2009:** The resolution provides that the amendment in the nature of a substitute recommended by the Committee on Small Business now printed in the bill shall be considered as an original bill for the purpose of amendment and shall be considered as read.
- **May 19, 2009:** Placed on the House Calendar, Calendar No. 56.
