Summary (as of May 20, 2009)

Recognizes World Hepatitis Day.

Expresses support for: (1) the goals and ideals of National Hepatitis Awareness Month; and (2) raising awareness of the risks and consequences of undiagnosed chronic hepatitis B and hepatitis C infections and the urgency for a robust governmental and public health response to protect the health of those who suffer from chronic viral hepatitis.

Actions Timeline

- **May 21, 2009:** Referred to the Subcommittee on Health.
- **May 20, 2009:** Introduced in House
- **May 20, 2009:** Referred to House Energy and Commerce
- **May 20, 2009:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **May 20, 2009:** Referred to House Foreign Affairs
