### Summary (as of Jun 3, 2009)

Expresses the heartfelt condolences of the House of Representatives to the families and friends of the victims of the May 11, 2009, shooting at the combat stress clinic at Camp Liberty, Iraq.

Conveys its ongoing deep gratitude to the brave members of the Armed Forces who risk their lives in service of protecting the nation.

Recognizes the important work of the medical professionals and staff members, who provide essential mental health services to our servicemen and women, at Combat Stress Control Center in Camp Liberty, Iraq, and other clinics in theater and at home.

Commits the House to: (1) focus on the mental, in addition to the physical, well-being of the nation's military servicemen and women, and veterans; and (2) support the policies, resources, and funding necessary to combat successfully the mental and physical healthcare challenges that they may confront.
