Summary (as of Mar 2, 2010)

Taking Responsibility For Congressional Pay Act - Reduces the rate of basic pay for each Member of Congress by 5%, rounded to the nearest multiple of \$100 (or, if midway between multiples of \$100, to the next higher multiple of \$100).

Declares that such adjustment shall be in lieu of any adjustment which (but for this Act) might otherwise take effect in 2011.

Actions Timeline

- **Mar 2, 2010:** Introduced in House
- **Mar 2, 2010:** Sponsor introductory remarks on measure. (CR H973)
- **Mar 2, 2010:** Referred to House Administration
- **Mar 2, 2010:** Referred to the Committee on House Administration, and in addition to the Committee on Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
