## Summary (as of Jan 13, 2009)

Victims of Crime Act Preservation Fund Act of 2009 - Excludes receipts and disbursements of the Crime Victims Fund from executive and congressional budgets.

Prohibits the consideration of any legislation in the House of Representatives or the Senate that would authorize the use of amounts in the Crime Victims Fund for a purpose not authorized by the Victims of Crime Act of 1984. Allows the Senate to waive or suspend such prohibition by a three-fifths vote.

## Actions Timeline

- **Feb 9, 2009:** Referred to the Subcommittee on Crime, Terrorism, and Homeland Security.
- **Jan 13, 2009:** Introduced in House
- **Jan 13, 2009:** Referred to House Budget
- **Jan 13, 2009:** Referred to the Committee on the Budget, and in addition to the Committees on Rules, and the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 13, 2009:** Referred to House Rules
- **Jan 13, 2009:** Referred to House Judiciary
