Summary (as of Mar 16, 2010)

Work-Life Balance Award Act - Establishes in the Department of Labor an annual Work-Life Balance Award for employers that have developed and implemented work-life balance policies.

Establishes a Work-Life Balance Advisory Board to develop criteria to determine recipients of the Award.

Actions Timeline
