Summary (as of Mar 25, 2010)

Amends the Patient Protection and Affordable Care Act (PPACA) to require the participation of the President, Vice President, each Member of Congress, each political appointee, and each Congressional employee in state Exchanges established for the purchase of health care coverage under such Act.

Actions Timeline

- **Mar 25, 2010:** Introduced in House
- **Mar 25, 2010:** Referred to House Oversight and Government Reform
- **Mar 25, 2010:** Referred to the Committee on Oversight and Government Reform, and in addition to the Committees on House Administration, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
