Summary (as of Mar 25, 2010)

Medicare Decisions Accountability Act of 2010 - Repeals sections of the Patient Protection and Affordable Care (PPACA) (and restores provisions of law amended by such sections) related to the establishment of an Independent Payment Advisory Board to develop and submit detailed proposals to reduce the per capita rate of growth in Medicare spending to the President for Congress to consider.

Actions Timeline

- **Apr 9, 2010:** Referred to the Subcommittee on Health.
- **Mar 25, 2010:** Introduced in House
- **Mar 25, 2010:** Referred to House Ways and Means
- **Mar 25, 2010:** Referred to the Committee on Ways and Means, and in addition to the Committees on Rules, and Energy and Commerce, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
