Summary (as of May 27, 2010)

Reform Americans Can Afford Act of 2010 - Repeals the Patient Protection and Affordable Care Act and the Health Care and Education Reconciliation Act of 2010, effective as of their enactment. Restores provisions of law amended by such Acts.

Enacts the Common Sense Health Care Reform and Affordability Act (H.R. 4038), as introduced in the House of Representatives on November 9, 2009.

Actions Timeline

- **Jun 29, 2010:** Referred to the Subcommittee on Health, Employment, Labor, and Pensions.
- **Jun 1, 2010:** Referred to the Subcommittee on Trade.
- **May 27, 2010:** Introduced in House
- **May 27, 2010:** Referred to House Energy and Commerce
- **May 27, 2010:** Referred to the Committee on Energy and Commerce, and in addition to the Committees on Appropriations, Ways and Means, Education and Labor, the Judiciary, Natural Resources, House Administration, and Rules, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
