Sets forth the rule for consideration of H.R. 2847 (Commerce, Justice, Science, and Related Agencies Appropriations Act, 2010).

Actions Timeline

- **Jun 17, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-158, by Ms. Slaughter.
- **Jun 17, 2009:** The rule provides that no further amendments shall be in order except: (1) amendments numbered 3,6,19,22,25,31,35,41,59,60,62,63 69,71,93,96,97,98,100,102,111,114, and 118 printed in the Congressional Record of June 15, 2009. (2) not to exceed 10 of the following amendments if offered by the ranking minority member of the Committee on Appropriations or his designee: amendments numbered 76,77,78,79,80,81,82,83,84,85,86,87,88,89,90,91,104,105,106,107 and 108 printed in the Congressional Record of June 15, 2009.
- **Jun 17, 2009:** Placed on the House Calendar, Calendar No. 74.
- **Jun 17, 2009:** Considered as privileged matter. (consideration: CR H6910-6918)
- **Jun 17, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 552.
- **Jun 17, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 238 - 180 (Roll no. 351). (consideration: CR H6917-6918)
