United States Marshals Service 225th Anniversary Commemorative Coin Act - Directs the Secretary of the Treasury, in commemoration of the 225th anniversary of the establishment of the United States Marshals Service, to mint and issue \$5 gold and \$1 silver coins emblematic of the 225 years of exemplary and unparalleled achievements of the U.S. Marshals Service.

Requires all such coin sales to include a surcharge of: (1) \$35 per \$5 coin; and (2) \$10 per \$1 coin. Requires distribution of the first \$5 million to the Director of the United States Marshals Service National Museum, for the preservation, maintenance, and display of artifacts and documents of the U.S. Marshals Service. Requires distribution of: (1) \$1 million to the National Center for Missing and Exploited Children; (2) \$1 million to the National Law Enforcement Officers Memorial Fund in support of the National Law Enforcement Museum and the National Law Enforcement Officers Memorial; (3) \$1 million to the Federal Law Enforcement Officers Association; (4) \$500,000 to the William "Bill" Degan Scholarship Fund (provides scholarships for spouses and children of law enforcement officers killed in the line of duty); (5) \$500,000 to the Robert D. May Scholarship Fund (provides scholarships for spouses and children of law enforcement officers killed in the line of duty); (6) \$500,000 to the Community Oriented Policing Service; and (7) \$500,000 to the United States Marshals Service Association.

Authorizes the Secretary to strike and sell bronze duplicates of the \$5 gold coins.
