Summary (as of Jun 23, 2009)

Sets forth the rule for consideration of the bill (H.R. 2647) to authorize appropriations for fiscal year 2010 for military activities of the Department of Defense, to prescribe military personnel strengths for fiscal year 2010.

Actions Timeline

- **Jun 24, 2009:** Considered as privileged matter. (consideration: CR H7215-7221)
- **Jun 24, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 572.
- **Jun 24, 2009:** POSTPONED PROCEEDINGS - The Chair put the question on ordering the previous question for H.Res. 572 and by voice vote, announced the ayes had prevailed. Mario Diaz-Balart (FL) demanded the yeas and nays and the Chair postponed further proceedings on the previous question on the resolution until later in the legislative day.
- **Jun 24, 2009:** Considered as unfinished business. (consideration: CR H7234-7235)
- **Jun 24, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 245 - 181 (Roll no. 451). (consideration: CR H7234-7235)
- **Jun 24, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 222 - 202 (Roll no. 452). (text: CR H7216)
- **Jun 24, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 222 - 202 (Roll no. 452). (text: CR H7216)
- **Jun 24, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Jun 23, 2009:** Introduced in House
- **Jun 23, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-182, by Ms. Pingree (ME).
- **Jun 23, 2009:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Armed Services now printed in the bill. In the engrossment of H.R. 2647 the Clerk shall add the text of H.R. 2990, as passed by the House, as new matter at the end of H.R. 2647. H.R. 2990 shall be laid on the table upon its addition to H.R. 2647.
- **Jun 23, 2009:** Placed on the House Calendar, Calendar No. 79.
