HOPE for Alzheimer's: Health Outcomes, Planning, and Education Act - Amends title XVIII (Medicare) to cover comprehensive Alzheimer's disease and other dementia diagnosis and services.

Requires the Federal Coordinated Health Care Office to study and report to Congress on: (1) barriers to the detection of Alzheimer's disease and other dementias for dual eligible individuals; (2) barriers to the furnishing of comprehensive Alzheimer's disease and other dementia diagnosis and services to such individuals; and (3) ways to eliminate such barriers.

Actions Timeline

- **Jul 29, 2010:** Introduced in House
- **Jul 29, 2010:** Sponsor introductory remarks on measure. (CR E1477)
- **Jul 29, 2010:** Referred to House Energy and Commerce
- **Jul 29, 2010:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jul 29, 2010:** Referred to House Ways and Means
