Sets forth the rule for consideration of the bill (H.R. 3081) making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2010.

## Actions Timeline

- **Jul 9, 2009:** Considered as privileged matter. (consideration: CR H7855-7862)
- **Jul 9, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 617.
- **Jul 9, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 617, the Chair put the question on ordering the previous question, and by voice vote announced that the ayes had prevailed. Mr. Lincoln Diaz-Balart (FL) demanded the yeas and nays and the Chair postponed further proceedings until later in the legislative day.
- **Jul 9, 2009:** Considered as unfinished business. (consideration: CR H7865, H7866)
- **Jul 9, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 217 - 187 (Roll no. 512). (consideration: CR H7862, H7865)
- **Jul 9, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 223 - 200 (Roll no. 513).(text: CR H7855)
- **Jul 9, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 223 - 200 (Roll no. 513). (text: CR H7855)
- **Jul 9, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Jul 8, 2009:** Introduced in House
- **Jul 8, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-193, by Mr. Cardoza.
- **Jul 8, 2009:** ALI points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. The Chair may entertain a motion that the Committee rise only if offered by the chair of the Committee on Appropriations or his designee. The Chair may not entertain a motion to strike out the enacting words of the bill. During consideration of H.R. 3081, the Chair may reduce to two minutes the minimum time for electronic voting under clause 6 of rule XVIII and clauses 8 and 9 of rule XX.
