Summary (as of Dec 19, 2009)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Amends the Continuing Appropriations Resolution, 2010 to extend from October 31, 2009, through December 23, 2009, appropriations and funds made available and authority granted pursuant to that joint resolution, unless either of the following occurs first: (1) the enactment into law of an appropriation for any project or activity provided for in this joint resolution; or (2) the enactment into law of the applicable appropriations Act for FY2010 without any provision for such project or activity.

Actions Timeline

- **Jan 13, 2010:** The Chair laid before the House the veto message from the President. (consideration: CR H48-49)
- **Jan 13, 2010:** The House proceeded with one hour of debate on the question of passage, the objections of the President to the contrary notwithstanding.
- **Jan 13, 2010:** POSTPONED PROCEEDINGS - At the conclusion of debate, the Chair put the question on passage, the objections of the President to the contrary notwithstanding, and announced that under the Constitution, the Yeas and Nays were ordered. The Chair then postponed further proceedings on the question until later in the legislative day.
- **Jan 13, 2010:** The Chair announced the unfinished business to be the consideration of the veto. (consideration: CR H104-105)
- **Jan 13, 2010:** Failed of passage in House over veto: On passage, the objections of the President to the contrary notwithstanding Failed by the Yeas and Nays: (2/3 required): 143 - 245, 1 Present (Roll no. 2).

- **Jan 12, 2010:** The Chair laid before the House the veto message from the President. (H. Doc. 111-84). In a Memorandum of Disapproval, the President stated the enactment of H.R. 3326 (Department of Defense Appropriations Act, 2010, P.L. 111-118), which was signed into law on December 19, 2009, has rendered the enactment of H.J. Res. 64 (Continuing Appropriations, FY 2010) unnecessary and accordingly, he is withholding his approval from the bill. In order to leave no doubt that the bill is being vetoed as unnecessary legislation, and in addition to withholding his signature, the President returned H.J. Res. 64 to the House along with the Memorandum of Disapproval . (consideration: CR H10)
- **Jan 12, 2010:** Pursuant to a previous order of the House, consideration of the veto message on H.J. Res. 64 is postponed until the legislative day of January 13, 2010.
