Summary (as of Nov 15, 2010)

American Recovery and Reinvestment Rescissions Act - Rescinds all unobligated balances remaining available as of November 15, 2010, of the discretionary appropriations provided by division A of the American Recovery and Reinvestment Act of 2009 (ARRA) (P.L. 111-5).

Prohibits federal agencies administering ARRA funds from providing funding or reimbursement to any entity awarded such funds for the cost associated with physical signage or other advertisement indicating that a project is funded by the ARRA.

Actions Timeline

- **Nov 15, 2010:** Introduced in House
- **Nov 15, 2010:** Referred to House Appropriations
- **Nov 15, 2010:** Referred to the Committee on Appropriations, and in addition to the Committees on Transportation and Infrastructure, and Oversight and Government Reform, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Nov 15, 2010:** Referred to House Transportation and Infrastructure
- **Nov 15, 2010:** Referred to House Oversight and Government Reform
