Summary (as of Jul 14, 2009)

Sets forth the rule for consideration of the bill (H.R. 3183) making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2010.

Actions Timeline

- **Jul 15, 2009:** By direction of the Committee on Rules, Ms. Matsui called up H.Res. 645 and asked for its immediate consideration.
- **Jul 15, 2009:** POINT OF ORDER - Mr. Flake raised a point of order against the provisions of H.Res. 645 because it violates the Congressional Budget Act. The Chair announced that the disposition of the point of order would be resolved by the question of consideration of H.Res. 645. The House proceeded with 20 minutes of debate on the point of order at the end of which the Chair will put the question on consideration.
- **Jul 15, 2009:** The Chair put the question of consideration of the resolution.
- **Jul 15, 2009:** On question of consideration Agreed to by voice vote.
- **Jul 15, 2009:** Considered as privileged matter. (consideration: CR H8107-8115)
- **Jul 15, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 645.
- **Jul 15, 2009:** On ordering the previous question Agreed to by the Yeas and Nays: 237 - 177 (Roll no. 538). (consideration: CR H8113-8114; text: CR H8113)
- **Jul 15, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 238 - 185 (Roll no. 539). (text: CR H8107)
- **Jul 15, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 238 - 185 (Roll no. 539). (text: CR H8107)
- **Jul 15, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Jul 14, 2009:** Introduced in House
- **Jul 14, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-209, by Ms. Matsui.
- **Jul 14, 2009:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. Points of order against provisions in the bill for failure to comply with clause 2 of rule XXI are waived. The Chair may entertain a motion that the Committee rise only if offered by the chair of the Committee on Appropriations or his designee. The Chair may not entertain a motion to strike out the enacting words of the bill. During consideration of the bill, the Chair may reduce to two minutes the minimum time for electronic voting under clause 6 of rule XVIII and clauses 8 and 9 of rule XX. House Resolution 618 is laid on the table
