(This measure has not been amended since it was passed by the House on September 29, 2009. The summary of that version is repeated here.)

United States Civil Rights Trail Special Resource Study Act of 2009 - Directs the Secretary of the Interior to conduct a special resource study to evaluate a range of alternatives for the protection and interpretation of sites associated with the struggle for civil rights in the United States, including alternatives for potential addition of some or all of the sites to the National Trails System. Requires submission of a report to Congress that contains the results of such study and recommendations of the Secretary respecting the route.
