Applauds Gail Abarbanel for founding the Rape Treatment Center and creating the Fast Track Forensics Program.

Commends the Rape Treatment Center for providing necessary services to sexual assault victims.

Calls upon local law enforcement agencies and state legislatures to work towards eliminating delays in processing rape kits.

Urges Congress to support programs for timely processing of DNA evidence.
