Summary (as of Jan 21, 2009)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

Declares that the House of Representatives: (1) observes the 80th birthday of Martin Luther King, Jr.; and (2) pledges to advance Dr. King's legacy.

Encourages the people of the United States to: (1) observe Dr. King's 80th birthday and his life; (2) commemorate his legacy so that, as Dr. King hoped, "one day this nation will rise up and live out the true meaning of its creed: `We hold these truths to be self-evident; that all men are created equal'"; and (3) remember Dr. King's message and rededicate themselves to his goal of a free and just United States.

Actions Timeline

- **Jan 21, 2009:** Mr. Conyers moved to suspend the rules and agree to the resolution.
- **Jan 21, 2009:** Considered under suspension of the rules. (consideration: CR H394-398)
- **Jan 21, 2009:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 73.
- **Jan 21, 2009:** Passed/agreed to in House: On motion to suspend the rules and agree to the resolution Agreed to by voice vote.(text: CR H394-395)
- **Jan 21, 2009:** On motion to suspend the rules and agree to the resolution Agreed to by voice vote. (text: CR H394-395)
- **Jan 21, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Jan 16, 2009:** Introduced in House
