Safeguarding America's Seniors and Veterans Act of 2009 - Directs the Secretary of the Treasury to make a one-time payment of \$500 to each eligible individual age 18 or over who, during the three-month period immediately preceding enactment of this Act, was entitled to Social Security benefits, railroad retirement benefits, or veterans disability benefits.

Actions Timeline

- **Jan 30, 2009:** Referred to the Subcommittee on Health.
- **Jan 28, 2009:** Introduced in House
- **Jan 28, 2009:** Referred to House Ways and Means
- **Jan 28, 2009:** Referred to the Committee on Ways and Means, and in addition to the Committee on Veterans' Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
- **Jan 28, 2009:** Referred to House Veterans' Affairs
