- **Sep 16, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 746.
- **Sep 16, 2009:** The previous question was ordered without objection. (consideration: CR H9566)
- **Sep 16, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 746, the Chair put the question on adoption of the resolution and by voice vote announced that the yeas had prevailed. Ms. Foxx demanded the yeas and nays and the Chair postponed further proceedings on adoption of the resolution until later in the legislative day.
- **Sep 16, 2009:** Considered as unfinished business. (consideration: CR H9569)
- **Sep 16, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 241 - 179 (Roll no. 703).(text: CR H9558)
- **Sep 16, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 241 - 179 (Roll no. 703). (text: CR H9558)
- **Sep 16, 2009:** Motion to reconsider laid on the table Agreed to without objection.
- **Sep 15, 2009:** Introduced in House
- **Sep 15, 2009:** The House Committee on Rules reported an original measure, H. Rept. 111-256, by Mr. Polis (CO).
- **Sep 15, 2009:** All points of order against consideration of the bill are waived except those arising under clause 9 or 10 of rule XXI. It shall be in order to consider as an original bill for the purpose of amendment under the five-minute rule the amendment in the nature of a substitute recommended by the Committee on Education and Labor now printed in the bill.
- **Sep 15, 2009:** Placed on the House Calendar, Calendar No. 108.
