Summary (as of Jan 28, 2009)

Commission on Financial Crisis Accountability Act of 2009 - Establishes the Commission on Financial Crisis Accountability to study and report to Congress on the U.S. financial system. Requires the Commission to examine the current financial crisis, its causes, and its impact on the federal deficit and tax revenues.

Actions Timeline

- **Jan 28, 2009:** Introduced in House
- **Jan 28, 2009:** Referred to House Financial Services
- **Jan 28, 2009:** Referred to the Committee on Financial Services, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
