Actions Timeline

- **Sep 25, 2009:** Considered as privileged matter. (consideration: CR H9965-9967; text of measure as reported in House: CR H9965)
- **Sep 25, 2009:** DEBATE - The House proceeded with one hour of debate on H. Res. 772.
- **Sep 25, 2009:** POSTPONED PROCEEDINGS - At the conclusion of debate on H.Res. 772, the Chair put the question on adoption and, by voice vote, announced that the ayes had prevailed. Mr. Dreier demanded the yeas and nays and the Chair postponed further proceedings on the question of adoption until later in the legislative day.
- **Sep 25, 2009:** Considered as unfinished business. (consideration: CR H9970)
- **Sep 25, 2009:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 209 - 189 (Roll no. 738).
- **Sep 25, 2009:** On agreeing to the resolution Agreed to by the Yeas and Nays: 209 - 189 (Roll no. 738).
